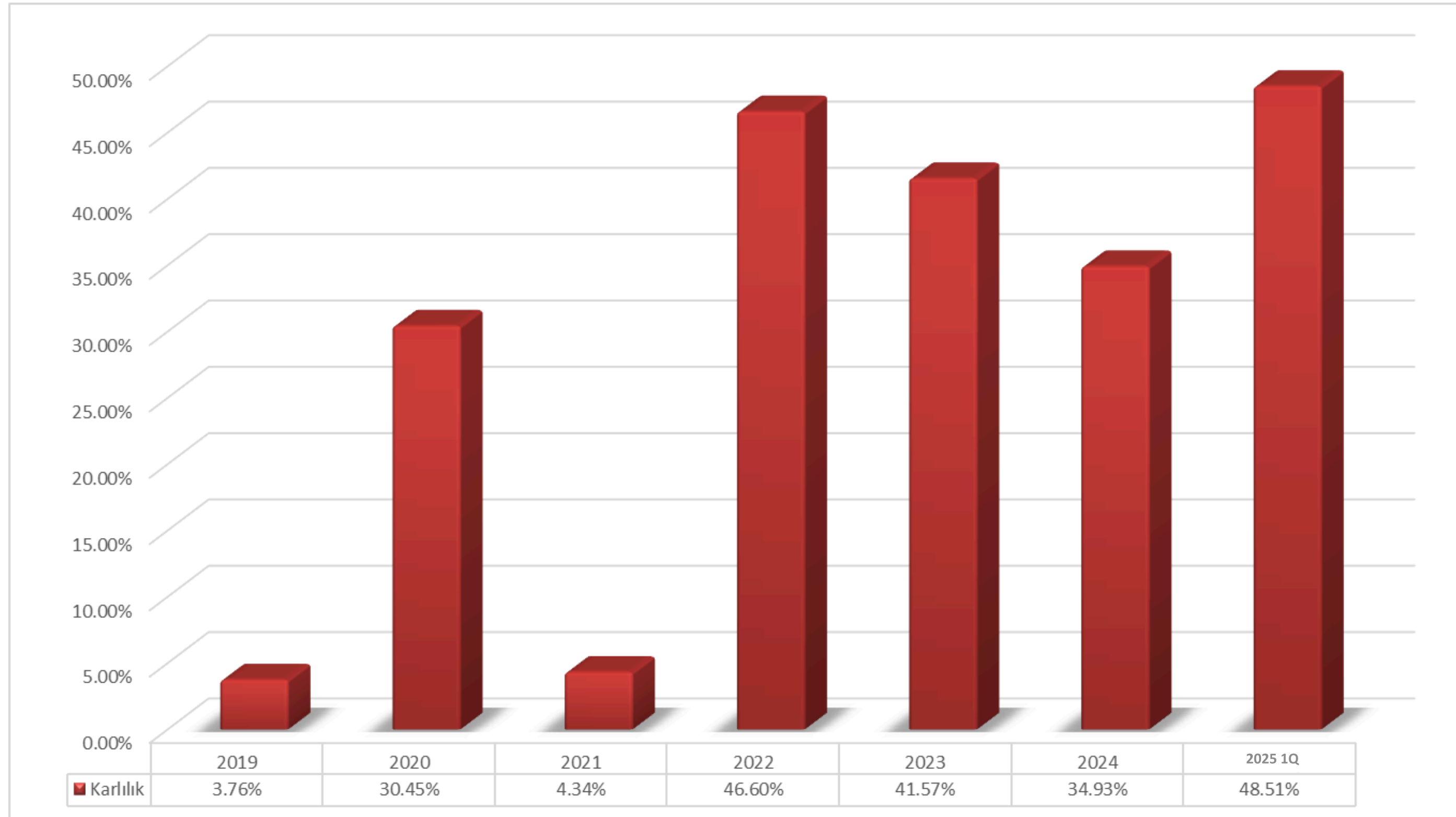

At this time, Global Investment Holdings Group operates in four key business areas:

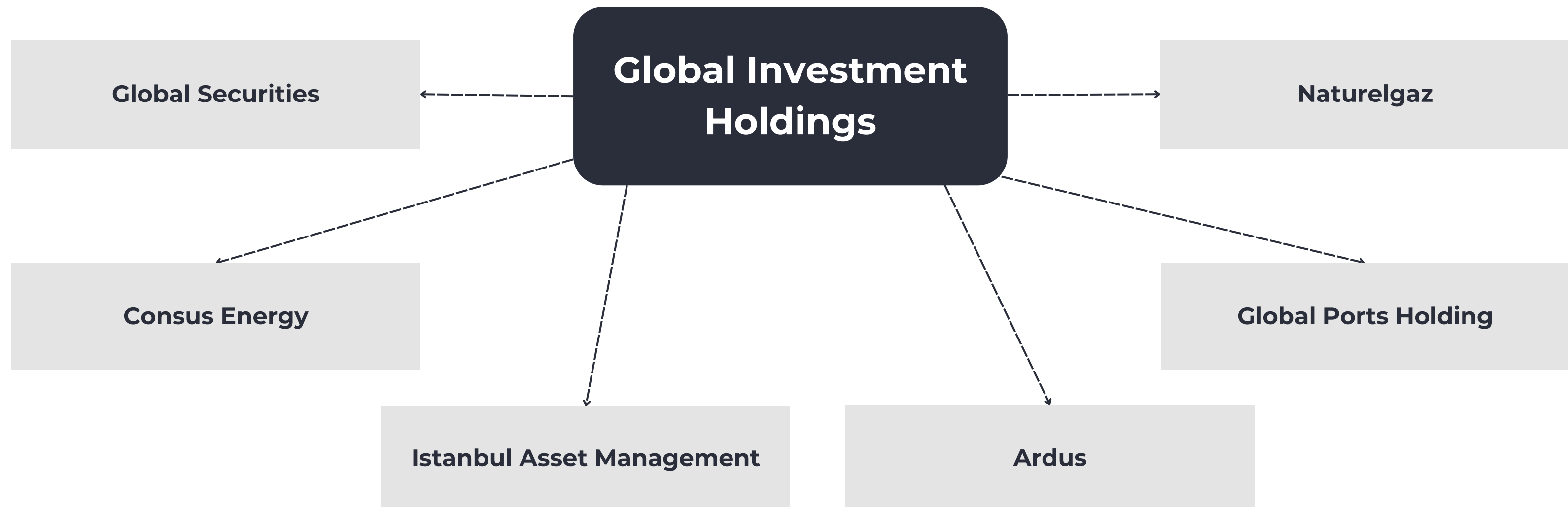
- **Port Infrastructure:** Operation of cruise ports and commercial sea - ports
